Proof of Commercial General Liability Insurance to be in full force and effect to a minimum of \$2 million. The policy must contain clauses providing \$2 million limit of liability coverage for bodily injury and property damage to spectators and participants, cross liability coverage and non-owned automobile coverage. The policy must contain a clause adding AEF, Officials, Judges, Course Designers, and Volunteers as "additional insured" with respect to the operations of the competition.
